Terms & Conditions

1. Course fees

- 1.1. For courses in South Africa, course fees exclude value-added-tax ("VAT") and are quoted in South African Rands. VAT is applicable.
- 1.2. For courses outside South Africa, course fees are quoted in the currency of the country in which the training takes place. Sales tax is not applicable.

2. Registration

- 2.1. Bookings will be accepted on a first come, first served basis and will be confirmed upon receipt of the completed booking form and the full course fee. **Please note that the number of delegates that can attend is limited. Book and pay early to avoid disappointment.**
- 2.2. If you register & pay the course fee before the early registration cut off date, you will qualify for the advertised discount ("early registration fee").
- 2.3. If more than one delegate from the same company registers for the same course on the same date, the 2nd and subsequent delegates qualify for the advertised discount on the course fee or on the early registration fee, if applicable.
- 2.4. Payment must be received 10 business days prior to the training event to confirm your booking. Bookings close 10 business days prior to the training event.
- 2.5. Upon receipt of your booking form, we will email you an invoice. If more than one person from the same company registered for the same course on the same date, the person whose details were entered first (Delegate #1) will receive the invoice and is responsible to arrange for payment.
- 2.6. Until full payment of the course fee, your booking is only provisional.
- 2.7. Upon receipt of full payment of the course fees, you will receive confirmation that your place has been booked for the training event.

3. Waiting list

- 3.1. If the course is fully booked, you may enter your details on a waiting list.
- 3.2. Should any bookings be cancelled, we will contact those on the waiting list to confirm interest to attend.
- 3.3. Enter all details on the waiting list booking form, including payment details, to expedite the booking should we receive any cancellations and you wish to attend.

4. Cancellation

- 4.1. All cancellations must be in writing.
- 4.2. The cancellation fee for cancellation more than 10 business days prior to the training event will be 25% of the course fee.
- 4.3. The cancellation fee for cancellation 10 business days or less prior to the training event will be 100%.
- 4.4. If a colleague wishes to attend in your place, please confirm in writing that you will no longer be attending and provide us with the person's contact details as soon as possible.
- 4.5. If we cancel a training event, all fees paid will be refunded to you.
- 4.6. Where training dates are changed, you may request a full refund if the new dates do not suit you.
